# 1) Status Update: Median Project – Town of Apple Valley

Orlando Acevedo, Economic Development Specialist II and Richard Pedersen, Deputy Town Engineer gave an updated report on the progress of the Median Landscape phase one. The proposal for engineering from Hall and Foreman, Inc. were approximately \$86,600 and were the recommendation from the Town's Engineering division. The landscaping was estimated at \$115,000. The PBID has approved an estimated expenditure of \$160,000 and the Town will apply for CDBG funding of an additional \$143,824.

The Town will present this proposal to the Town Council on May 12, 2009 for approval. If approved, the application will be sent by May 15, 2009 to HUD for final approval.

No Board Action necessary as this was informational only status report.

Part 1-Where can all documents for PBID be obtained. Answer: The Town or at the meetings at this time. Question if you terminate your membership rights will you still be assessed if you opt out? Answer: Chairman Cambridge, I would assume so but I would have to get clarification on that. Part 3- The Town owns property in the Village and has voting rights, is that a conflict of interest. Answer: Chairman Cambridge, will get a legal opinion on conflict of interest between The Town and PBID.

- 2) **Sharon Holland:** Wants to know what impact the Median Landscape will have on raising the value of her property. She wants the actual % of return she will receive personally on this economic development. **Action:** Chairman Cambridge to contact Economic Development at the Town to obtain some type of % for her.
- 3) **Kim Scully:** Wants to postpone PBID until economy strengthens. **Action:** Chairman Cambridge to meet with her after meeting.
- 4) She also request documents on the PBID votes, Board election, Treasurer report from start of PBID, copy of owners and copy of ballot for PBID. SOLUTION: Complete-Soni gave her all requested documents with the help of Orlando Acevedo from the Town.
