## Apple Valley Village Property Business Improvement District Board Meeting Minutes – May 17, 2017

# I. CALL TO ORDER:

# d) Status Update: PBID Renewal – Donna Gilmore

Treasurer Gilmore stated that she would have Ed speak and give an update.

Ed gave an update on the signed petition status and stated that the current level is just over 35% (>50% needed). The Board will continue to garner support for the renewal process by getting more signatures for the petition phase. Ed stated that we are looking at placing the PBID renewal on the June 27, 2017 Town Council Meeting so that a Town Council public hearing can be scheduled for August 8, 2017 and the Year 1 PBID renewal assessments can be placed on the 2017-18 San Bernardino County property tax rolls. (UPDATE NOTE: Sufficient petitions were received on June 2 and the Town Council approved a Resolution of Intention to renew the PBID at their June 13th meeting and set the public hearing for August 8th - ballots will be sent out to each owner by Friday June 23rd)

## e) Status Update: Sheriffs Department – Joy Ballinger

Sergeant Laura from the PD gave the PBID Board the statistics report to review regarding the calls/incidents taken place during the last month.
